**Objectives:**

- Discuss the principles of Catholic Social Teaching that may be considered in clinical practice.
- Identify the unique position of young women in medicine and the challenges they face within their various family and professional obligations.
- Describe the different possibilities that modern medicine has available to utilize one's education and training in a meaningful way.
- Discuss the ways to identify one's own unique intellectual gifts to ensure fulfillment in her medical career.
- Examine opportunities in medicine where taking a psychosocial-spiritual approach to patient care can lead to better outcomes and increased job satisfaction.
- Formulate communication skills for challenging areas in medicine.

- Propose a strategy for showing compassion to patients, patients' families, and coworkers while remaining resilient against burnout.
- Discuss the importance of consistency in clinical practice and conformity to the mission of the healthcare team.
- Describe how immune reconstitution after allogeneic hematopoietic cell transplantation may serve as a model how to effectively conform to a new state of well-being.
- Identify, illustrate, and assess potential areas of conflict in clinical practice, between secular and faith-based approaches to the value, at all stages of life, of the human being as a patient.
- Describe the bio-psycho-social-spiritual-family context for understanding the chronic illness experience.
- Compare and contrast treatment planning in addictive disease and chronic pain management.
- Assess the readiness for behavior change and responding consistently.
