## The Thomas C. and Sandra S. Sullivan Foundation Grant Making Guidelines

<b>Mission:</b>	Assist and/or provide educational opportunities to those persons who would otherwise not be able to provide such opportunities to themselves, and provide aid to the poor and needy, primarily in greater Cleveland.
<b>Focus Areas:</b>	Catholic and other nonprofit organizations in greater Cleveland and those areas where Sullivan family members reside.
<b>Types of Grants:</b>	The Foundation provides operating and program support to organizations that serve the poor and needy. The goal is to fund programs with a record of success in making a profound improvement in the lives of disadvantaged members of our community.
<b>Sample Projects:</b>	<p>Cleveland Central Catholic High School, increasing the total amount of tuition assistance available for the most-needy students to attend.</p> <p>May Dugan Center, supporting operations and ongoing programming to ensure successful outcomes to clients.</p> <p>Fill This House, providing household necessities for Cuyahoga County newly emancipated youth “aging out” of foster care.</p>
<b>Eligibility:</b>	Social service agencies and nonprofit organizations in Cuyahoga county.
<b>Award:</b>	The range for grant awards is \$1,000-\$25,000. The average grant in 2022 was \$10,780.00
<b>Deadline:</b>	July 15. Please include your organization’s most recent audited financial reports or review (dated no more than three years ago) by an outside accounting firm.
