# 3 STEPS TO SUPPORT OUR CATHOLIC SCHOOL STUDENTS

### STEP 1 *Can I Take the Full Credit?*

Take a quick look at your last year's Ohio state tax return to estimate tax liability for the current year. The maximum tax credit is \$750 for single filers. If you are filing a joint return and both you and your spouse make eligible donations, each of you can claim this credit (up to \$1,500 total).

### STEP 2 *Contribute by April 15, 2026*

Choose the General Scholarship Fund, which serves the schools of greatest need, or designate the school(s) of your choice. Your generosity is the key for providing the maximum number of scholarships to students in need. \*Contribution can be any amount. The amount of the tax credit cannot exceed the amount of your tax liability.

### STEP 3 *Claim Your Tax Credit On Your Ohio Income Tax Return*

A tax receipt will be provided that documents your Angel Scholarship Fund contribution. This receipt is then submitted with the Ohio 1040 tax form.

#### EXAMPLE OF OHIO TAX CREDIT SCENARIO\*

INDIVIDUAL	MARRIED, FILING JOINTLY		
Ohio Income Tax owed	\$1,000	Ohio Income Tax owed	\$2,000
Tax Credit on \$750 Contribution to the Angel Scholarship Fund	- \$750	Tax Credit on \$1,500 Contribution to the Angel Scholarship Fund	-\$1,500
Ohio Income Tax owed after Tax Credit	\$250	Ohio Income Tax owed after Tax Credit	\$500
