## HOW IS THIS “NO COST TO YOU”?

- Your donation will reduce your Ohio income tax liability on a dollar-for-dollar basis. That is, money that ordinarily would have been owed to the State of Ohio can be “redirected” to fund Catholic education scholarships.
- **Sample Net Result:** Let's assume that, normally, after tax credits and deductions, your family's Ohio income tax is \$2,000. Look at the positive impact a \$1,500 (if married filing jointly) impact can have for you. →

## FREQUENTLY ASKED QUESTIONS

### **What is the Angel Scholarship Fund?**

Because of new Ohio tax legislation in 2021, the Catholic Community Foundation has established the Angel Scholarship Fund to support our Catholic Schools. This program is a way to “turn tax dollars into tuition” because those who make a scholarship contribution receive an Ohio income tax credit equal to the total amount of their contribution (\$750 annual maximum credit or \$1,500 if married where each spouse makes a \$750 contribution).

### **Who will benefit from this Scholarship Tax-Credit Program?**

Catholic school students (priority given to low-income families) can apply to receive scholarships and thus, many more students will be able to seek a Catholic school education. Also, donors benefit by receiving a reduction in their Ohio income tax liability equal to their contribution (up to maximum limit).

### **May Angel Scholarship Fund contributions be made only once or may they be made every year?**

You are permitted to make a contribution every year and will continue to receive a corresponding tax credit over and over again each new year.

### **Who can contribute to the Angel Scholarship Fund?**

Anyone. However, only those persons with Ohio tax liability may be eligible for the tax credit.

### **Are you permitted to designate your Angel Scholarship Fund contribution to a specific student?**

No.

### **Are you permitted to designate your Angel Scholarship Fund contribution to a school of my choice?**

Yes. Donors to the Angel Scholarship Fund have the option of making:

a.) An undesignated contribution that supports schools and students across the Diocese of Cleveland.

b.) A contribution that is designated to benefit students of a specific Catholic school.

In either case, scholarships to low-income families will be prioritized.
